### **E - Expected income was fully received and properly recorded – NO**

A lack of a clear audit trail for income increases the risk of financial loss or error and undermines confidence in the transparency of operations.

My Internal Audit Report has recommended to Council to implement proper invoicing, consistent recording of receipts, and retention of supporting documentation for all income sources.

### **L -The authority published the required information on a website/webpage – NO**

Failure to publish statutory documents breaches the Transparency Code 2015 and ICO expectations under the Model Publication Scheme

The Council is updating its website and will ensure all required information, including meeting agendas, minutes, financial statements, and AGAR documents, are published promptly and consistently going forward.

### **M - The authority, during the previous year, correctly provided for the exercise of public rights – NO**

Failure to provide the correct public notice period for inspection of the accounts is a breach of the Accounts and Audit Regulations 2015.

Another extension has been applied for this year as the original Internal Auditor cancelled the planned review due to ill health. However, it is hoped that the Clerk will try to ensure correct procedures and statutory timescales are followed for the 2024/25 AGAR.

### **N - The authority complied with the publication requirements for 2023/24 AGAR – NO**

Failure to meet the statutory publication requirements under the Accounts and Audit Regulations 2015

The Council will no doubt take steps to ensure that the full 2024/25 AGAR, including the signed Annual Governance and Accounting Statements and the Notice of Conclusion of Audit, is published in full compliance with the legal deadlines.

## Guidance notes on completing Form 3 of the Annual Governance and Accountability Return (AGAR) 2024/25
